Constitution of the United States Article VI

"This Constitution, and the laws of the United States...shall be the supreme law of the land; and the judges in every state shall be bound thereby, anything in the Constitution or laws of any State to the contrary notwithstanding.

The Senators and Representatives before mentioned, and the members of the several state legislatures, and all executive and judicial officers, both of the United States and of the several states, shall be bound by oath or affirmation, to support this Constitution...."

Title 18, USC, Section 242

It makes it a crime for a person (federal, state, or local officials, police officers and other law enforcement, as well as judges, care providers in public health facilities public schools, & other public officials) acting under 'color of law' to willfully deprive a person of a right or privilege protected by the Constitution if said person(s) purport to act in the performance of his/her duties.

There is no legal precedent or legal authority for the United States government to "lockdown" its citizens. Know your rights.

- The United States Supreme Court has ruled in Shelton v. Tucker 364 U.S. 479 (1960) that the government cannot broadly curtail personal liberty. And there is no legal precedent or authority for locking down healthy citizens. The police power of quarantine only is possible against ill persons. Jew Ho v. Williamson 103 F. 10 (1900) and Wong Wai v. Williamson 103 F. 384 (1900).
- Current mandates & directives have no force of law behind them.
- No legislature has passed any laws regarding these mandates.
- No governor or mayor or commissioner can make law.
- Every test that shows positive is a new case even if it is done on the same person multiple times. This inflates the numbers.
- PCR tests analyze genetic matter from the virus in cycles and today's tests typically take 37 to 40 cycles, but experts say this is too high because it detects very small amounts of the virus that don't pose a risk.
