What you need to do:

4. Email the democratic member of this committee. Tell them why this bill is important to you. Why it should be heard and passed.

Talking points:

1. AB93 limits the power of one man to make all the decisions and instead allows the legislature to become part of the decision-making during emergencies. This is a much better balance of powers.
2. This emergency has gone on for far too long and damaged far too many livelihoods, businesses, families, children, etc. A decision like this must involve more of our elected officials and more representatives of the People.
3. Current law puts NO LIMIT AT ALL on the time frame for a declared state of emergency. This is far too much power in the hands of the executive branch. We simply want more emphasis placed on the balance power with the legislative branch of government.
4. Fifteen days is amply time for quick, emergency action, under the dictates of the governor alone. After 15 days, the legislature should be allowed and able to step in and conduct the business for which they were elected, which is to represent the varied needs of their constituents.
5. Emergency powers should be just that, **emergency**. Not powers that stretch out over months and years, long after the immediate threat of death or destruction has ceased. Emergency powers are meant to simply get things under control when the world is under siege. Once the chaos has passed, the government should go back to its regular workings. An

extended state of emergency under the dictates of one person is corruption of our form of government which is dependent on the balance of the 3 branches of government.

- C. Call Chairman Flores and ask that he HEAR the bill. Let him know how important all of this is to you and Nevada. He is a lawyer and a logical man. Appeal to his logic, fairness and the democratic process.
- D. Be respectful. Continue emailing if you don't hear back.
- E. Call all the members. Ask them to push to have the bill heard. Once it is scheduled to be heard, pressure them to pass it.

Exerpt from AB 93:

“Section 2 of this bill [AB93], provides that a state of emergency or declaration of disaster proclaimed by the Governor terminates automatically 15 days after it is proclaimed by the Governor. However, section 2 provides that a state of emergency or declaration of disaster may continue beyond that 15-day period if

the Legislature, by resolution, expressly approves the continuance. Additionally, if a state of emergency or declaration of disaster proclaimed by the Governor terminates, section 2 prohibits the Governor from subsequently proclaiming the existence of a state of emergency or declaration of disaster due to the same occurrence or threatened occurrence as that of the terminated emergency or disaster unless the Legislature, by resolution, expressly approves the proclamation. Finally, if the exercise of any emergency power by the Governor would impose a requirement on or otherwise restrict the operation of a business in this State, sections 1 and 2 of this bill prohibit the Governor from exercising such a power without the express approval of the Legislative Commission or Legislature. Section 3 of this bill applies the provisions of section 2 to states of emergency or declarations of disaster proclaimed by the Governor that are in effect on the effective date of this bill. However, under section 3, a state of emergency or declaration of disaster proclaimed by the Governor that is in effect on the effective date of this bill terminates 10 days after the effective date of this bill, rather than 15 days after the date upon which the emergency or disaster was proclaimed."
