Comes now Affiant, \_\_\_\_\_, one of the  
People (as seen in Nevada Constitution's Bill of Rights Article 1 Section 2), Sui  
Juris, in this Court of Record, do hereby submit the following counts of voter fraud  
claims obtained from investigations:

- a. 3,987 Non-Citizens
- b. 1,506 Deceased Voters
- c. 2,468 Change of Address to Out of State
- d. 42,284 Duplicate Voters
- e. 15,164 Non-Nevada Mailing Addresses
- f. 8,842 Commercial Registration Addresses
- g. 8,111 Non-Existent Addresses (vacant lots)
- h. 8,529 Reactivated (from non-active) Votes by Mail
- i. 60 Voters with the name "Resident" in Clark County

**Please take notice that:**

All government, of right, originates with the People, is founded upon their will only and is instituted solely for the good of the whole. Public officers are the trustees and servants of the People and at all times are amenable to the People.

**Nevada Constitution Article 15 Section 2: "Oath of office"**

*Members of the legislature, and all officers, executive, judicial and ministerial, shall, before they enter upon the duties of their respective offices, take and subscribe to the following oath:*

*I, ....., do solemnly [solemnly] swear (or affirm) that I will support, protect and defend the constitution and government of the United States, and the constitution and government of the State of Nevada, against all enemies, whether domestic or foreign, and that I will bear true faith, allegiance and loyalty to the same, any ordinance, resolution or law of any state notwithstanding, and that I will well and faithfully perform all the duties of the office of ....., on which I am about to enter; (if an oath) so help me God; (if an affirmation) under the pains and penalties of perjury.*

Please Take Notice of your "Oath of Office" you have sworn to uphold which constitutes a Contract with the People of Nevada. As bonded Trustees and indentured Servants it is your duty to carry out the wishes of the People who granted the authority for you to handle the Peoples' business. The People have the absolute right to regulate their internal government, and are guaranteed the right to reform, alter, or abolish government whenever the public good may require it. Therefore, I am presenting fundamental law and instructions for you to observe and carry out as the will of the People (Observe the Constitutional Provisions supporting this authority below):

**Nevada Constitution Article 1 Section 10: "Right to Assemble and Petition"**

*"The People have the right freely to assemble together to consult for the common good, to instruct their representatives and to petition the Legislature for redress of grievances."*

**Nevada Constitution Article 1 Section 2:  
“Purpose of government; paramount allegiance to United States”**

*“All political power is inherent in the people. Government is instituted for the protection, security and benefit of the People; and they have the right to alter or reform the same whenever the public good may require it.”*

**Nevada Constitution Article 2 Section 1 and Section 1A: “Right of Suffrage”**

**Section 1A #11.** *“To have complaints about elections and election contests resolved fairly, accurately and efficiently as provided by law.”*

Please Take Further Notice: Nevada civil officers guarantee that they will not interfere with the right of suffrage, yet the Peoples’ requests for discovery and investigations have been ignored and denied! The People of Nevada have not been effectively represented as the Peoples’ complaints regarding the 2020 elections have not been fairly and/or accurately resolved. Our existing government has willfully prevented the People from being able to accurately and effectively determine all legal votes and therefore have violated the Peoples’ constitutional rights and your oaths of office.

The Nevada Constitution clearly shows that out of the votes, scrutiny must be done to reduce them to legal votes. This is sworn to by all elected officials and workers in the state as part of the agreement to work for the People of Nevada. The Audit of the votes and systems is the right of the People to know that elections are accurate, equitable and free of fraud.

THEREFORE, it is the Will, Order and Demand of Your Affiant that a full Forensic Audit of Clark and Washoe Counties be conducted immediately for the purpose of due diligence by ensuring integrity and accuracy. The Forensic Audit shall be full and complete of all paper ballots both in person and absentee, all Machines, related software, ballots, routers and internet devices. The People of Nevada want in addition a review of the examination/ certification/ testing report for ballot reader equipment and related software, the Escrow purchase agreement and addendums to the contract of all Electronic Voting Machines such as Dominion and any other election related manuals, materials and systems. The Forensic Audit shall make provisions for Democrat, Republican, and Independent representatives. Furthermore, “We the People” demand that the legislature work with the People to secure a well-balanced Forensic Audit. Results of the Forensic Audit shall be made available to the public upon completion.

This is an Affidavit and Contract and change of terms. Any government official that believes these claims are untrue must respond within five (5) days upon receipt with Constitutional Provisions, sworn under the penalty of perjury, by Affidavit, and rebut each claim point by point, showing where you have Constitutional Authority to ignore these rights of the People. Any government official, who decides to ignore and/or to suppress this affidavit by not responding by the terms as set forth, agrees to pay Ten Thousand Dollars (\$10,000.00) per day for failing to immediately make provisions for a Forensic Audit. Failing to respond with constitutionally granted authority which gave you the power to disregard the Peoples' rights mentioned within this Affidavit and Contract, means that you agree to have this Affidavit used against you as evidence of Maladministration. You further agree that once the five (5) day time period is up, this Affidavit becomes truth and law and that you agree, by acquiescence, that you are knowingly interfering with the rights of the People you swore to protect, and that this Affidavit shall stand as evidence that you are acting in Maladministration and that no court shall have the power to again adjudicate these matters and that all Courts of Record shall accept this Affidavit as truth and law. You also agree to be bound by all said herein and the Affiant is able to bring this Contract before an Arbitrator of Affiant's choice at the sole expense of you, and you agree to be bound by any award.

If you cannot prove that you are acting under constitutional authority please take further notice that any denial of protection and maintenance of the Peoples' individual rights is **Maladministration, Treason and Insurrection**. Failure to respond means that by acquiescence you agree that all claims stated herein are true and correct without exception. Remedy shall be had by giving the People a full Forensic Audit as outlined above.
